## <u>MIGRANTS</u> WHATS IS IT?

Migrants, people that choose to move, seeking work, health or education in order to provide a better quality of life, for family reunion or other reasons. Migrants keep receiving protection from their governments.

Immigrants, people that imigrates, that is, enters a foreing country to live in it.

Emmigrants, that who emigrates, that is, goes away from one country to live in another.

Refugees, people who escape from armed conflicts or persecutions in their countries and that cross international frontiers to search for safety and cannot come back to their original country.



### **MIGRANTS RIGHTS**

#### **TO NOT BE DISCRIMINATE**

Nobody can have their rights restricted in reason of their skin color, beign a woman or child, by their sexual orientation, their social situation, economic conditions or religious beliefs. Racism is a crime in Brazil as is religious intolerance. Victims of racism, insults or religious intolerance have the right to receive and formalizetheir complaint through the help of Rede Refúgio, through the specialized channels available in São José do Rio Preto or at police stations.

#### TO NOT SOFFER FROM SEXUAL AND GENDER VIOLENCE

In Brazil, man and women have the same rights and any form of violence based on gender or sexual orientation is a crime. Victims of domestic violence have the right to receive medical assistance and file a complaint through the channels available in São José do Rio Preto, catering services (CRAM) or police stations specialized in women's care (DDM).

## HEALTH

Refugees, as any other foreign, can and should receive hospital and clinical publical care in all national territory.

Brazilian legislation secures that all the services provided by the Unic Health Care System are universal, free of charge and accessible to all individuals in Brazil territory. For that you must present your CPF ( social security number ) or RNM at any public hospital, clinic or health post and request your SUS Card. This card is free and can be utilized at any public health unity in all national territory.

In Brazil, the parents have the obligation to vaccinate their childrens. The children of refugees can freely obtain vaccines in healthcare posts.

#### **EDUCATION**

The refugees have the right to attend at public elementary and high schools , as well as to participate in public health programs and technical and professional capacitacion . They can also access university education , in the same mold of Brazilians or through special refugee university admission programs.

#### FREELY PRACTICE YOUR RELIGION

Brazil is a secular country that assures full freedom of worship, religion and belief .



#### FLEXIBILITY IN THE REQUIRED DOCUMENTS NECESSARY TO PRESENT FROM THE COUNTRY OF ORIGIN.

According to the article 43 from the refugees brazilian law, brazilians institutions have to consider the difficulties, from the refugees, to obtain and present the documents issued in their country of origin or consular and diplomatic representations

#### **DOMESTIC VIOLENCE AGAINST WOMEN**

In Brazil, domestic or familiar violence against women is punished with major severity by the Maria da Penha Law number 11.340/2006. This law punishes physical, psychological, sexual, patrimonial and moral acts of violence against woman, independetly of their age. The law also provides a protection mechanism for the woman victim of domestic violence, with the possibility of urgent concession to protective measures and referral to services of reception, care, follow-up and shelter, when necessary.

#### HOW TO ACT IN CASE OF VIOLENCE

If you go to the nearest Emergency Room and inform, during the service, the violence suffered. Rio Preto has Police Stations Specialized in Assistance to Women, with professionals trained to assist women victims of violence. However, the complaint can be made at any police station. In rio preto there is the Center for Reference and Assistance to Women - CRAM on the available phones:

### **OBRIGAÇÕES DOS REFUGIADOS (AS) NO BRASIL**

Respect all the laws. Respect the people as well as public and private entities and organisms

Renew your RNE ( migrants persons card ), National Migration Registry (RNM) or you ID

Inform your home address, keeping updated at the federal police stations together with the CONARE

The refugees who had their condition recognized by Brazil only may travel abroad with authorization from the CONARE. the refugees who leave Brazilian territory without authorization from the CONARE (conare@mj.gov.br) are subject to the loss of their status as refugee.

a recognized refugee by CONARE will only bear the condition of refugee in Brazilian territory. The other countries are not obliged to recognize as a refugee a person who has already been recognized elsewhere.
